### TERMS AND CONDITIONS

1. Members can access up to 150% of total contributions as short-term loans.
2. Maximum tenor for a short-term loan is 3 calendar months, and interest is chargeable at 7.00%.
3. Interest rate is flat for short-term loans. Interest is charged on the loan upfront, lumped with principal and repayment of total sum spread over 3 months or with one bullet payment of principal and interests due at the end of the tenure of the loan.
4. The beneficiary shall deposit post-dated checks with the Society to cover the loan in accordance with the tenure of the loan and repayment plan.
5. In the event of default in payment of loan, the society shall reserve the right to deduct from member's savings, or at source from salary, any sum due including interest and bank charges arising from such transaction.
6. If the beneficiary cease to belong to the cooperative society, or resigns his / her employment with OERNL / NAE / AENR during the tenure of this loan, the outstanding amount shall be deducted from the member's terminal benefits.
7. The beneficiary shall abide by the loan repayment plan of the cooperative society (a copy is obtainable from the society's office)
